



Acknowledgement, Waiver and Release for Communicable Diseases Including COVID-19

In consideration of participation in a Georgia Middle School Athletic Association (GMSAA) program and specifically Cambridge Jr. Cheer Inc. Program related events and activities, the undersigned acknowledges and agrees that:

1. I/We understand that participation includes possible exposure to and illness from infectious diseases including by way of illustration but not as limitation to MRSA, influenza, and COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and,
2. I/We knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the releasees or others, and assume full responsibility for my student's participation; and,
3. I/We willingly agree to comply with the stated and customary terms and conditions for participation regarding protection against infectious diseases. If, however, if any unusual or significant hazards are observed during my student's presence or participation, he/she will remove himself/herself from participation and bring such to the attention of the nearest official immediately; and,
4. I/We hereby release and hold harmless GMSAA officers, officials, agents, and/or coaches, other participants, sponsoring agencies, sponsors, county school district, school and if applicable, owners and lessors of premises used to conduct the event ("Releasees"), with respect to any and all illness, disability, death, or loss or damage to person or property, whether arising from the negligence of releasees or otherwise, to the fullest extent permitted by law.
5. I/We specifically hereby release and indemnify and hold harmless Cambridge Jr. Cheer Inc. officers, officials, agents, coaches, administrators and Cambridge Jr. Cheer Inc. Board Members, with respect to any and all illness, disability, death, or loss or damage to person or property, whether arising from the negligence of releasees or otherwise, to the fullest extent permitted by law.
6. I/We specifically acknowledge and agree that before my student's participation in any tryout, team practice, or team related event, I/we will have taken the temperature of my student participant and will have answered ALL screening questions outlined on the GMSAA website (i.e. Do you or have you had a fever in the last two weeks, have you been diagnosed with COVID-19, etc.). If my student participant answers YES to any of the outlined questions, I/we specifically acknowledge and agree that my student will NOT participate in any tryout, team practice, or team related event for at least 14 (fourteen) days, or when the symptoms no longer exist, whichever is longer. However, my student participant may return sooner with verification of a negative COVID-19 test or release from my student's physician.
7. I/We specifically acknowledge and agree that virtual or video tryouts as well as in person tryouts ARE AVAILABLE for the 2020 Cambridge Jr. Cheer Inc. Program.

By signing below, I/we acknowledge that we have carefully read this voluntary Waiver and understand the potential dangers incident to engaging in interscholastic athletics, sports teams/clubs and events, and are fully aware of the legal consequences of this agreement.
